LEWIS DONEY received his BA (Religious Studies) from Lancaster University in 2002, and his MA and Ph.D. (Studies of Religions) from the School of Oriental and African Studies, in 2004 and 2011. His thesis charts the metamorphosis of kingship ideals in Tibetan histories between the 8th and 12th-century, through the prism of representations of Khri Srong lde brtsan (742-c. 800 CE). He has just completed a book with the title *The Zangs gling ma: The First Padmasambhava Biography. Two Exemplars of its Earliest Attested Recension* (International Institute for Tibetan and Buddhist Studies, 2014).

JACOB DALTON, Khyentse Foundation Distinguished Professor in Tibetan Buddhism at UC Berkeley, received his Ph.D. in Buddhist Studies from the University of Michigan in 2002. After working for three years as a researcher with the International Dunhuang Project at the British Library, he taught at Yale University before moving to Berkeley. He is the author of *The Taming of the Demon: Violence and Liberation in Tibetan Buddhism* (Yale University Press, 2011) and coauthor of *Tibetan Tantric Manuscripts from Dunhuang: A Descriptive Catalogue of the Stein Collection at the British Library* (Brill, 2006).

FRANZ-KARL EHRHARD is Professor of Tibetan and Buddhist Studies at the Ludwig-Maximilians-Universität Munich, Germany. His research work centres on the religious and literary traditions of Tibet and the Himalayas. A collection of articles has been published with the title *Buddhism in Tibet and the Himalayas: Texts and Traditions* (Vajra Publications, 2013) and he is author of *A Rosary of Rubies: The Chronicle of the Gur-rigs mDo-chen Tradition from South-Western Tibet* (Indus Verlag, 2008).

MARC-HENRI DEROCHE is Assistant Professor at Kyoto University, Hakubi Center for Advanced Research and Graduate School of Letters, Department of Buddhist Studies. He received his Ph.D. from the École Pratique des Hautes Études, Paris, in 2011 and has investigated in this thesis and in a series of articles the life and works of 'Phreng po *gter ston* Shes rab 'od zer (1518-1566). In 2009, he co-organized the Second International Seminar of Young Tibetologists in Paris, and co-edited its proceedings volume *Revisiting Tibetan Religion and Philosophy* (Amnye Machen Institute, 2012).

NIKOLAI SOLMSDORF received his MA and Ph.D. in Tibetan and Buddhist Studies at the Ludwig-Maximilians-Universität, Germany, in 2008 and 2013. His dissertation deals with the life of Rig 'dzin Gar dbang rdo rje snying po (1640-1685), the so-called "Treasure-Discoverer from Western Tibet" (*mnga' ris gter ston*). He serves presently as research assistant at the Bavarian Academy of Science and Humanities.

FRANÇOISE POMMARET is a cultural anthropologist, Director of Research at the CRCAO, CNRS (National Centre for Scientific Research), Paris. She has been associated with Bhutan in different capacities since 1981 and is now Adjunct Professor at the Institute of Language and Culture (ILCS, Royal University of Bhutan).
