**Alexander I. Andreev** is Doctor of History (*doctor istoricheskikh nauk*), a Leading research fellow of the St. Petersburg Branch of the Institute of History of Natural Science and Technology (1995-2018). A historian of Inner Asia and Tibet, he has numerous publications on Russo-Tibetan relations among which are *Soviet Russia and Tibet. The Debacle of secret diplomacy, 1918–1930s* (Leiden: Brill, 2003); *Tibet v politike tsarskoi, sovetskoi i postsovetskoi Rossii* Тибет в политике царской, советской и постсоветской России [Tibet in the policy of Tsarist, Soviet and Post-Soviet Russia] (Nartang, St.-Petersburg, 2006). His most recent publications are *Navstrechu nevedomim miram. Fantasticheskie rasskazy, skazky* Навстречу неведомым мирам. Фантастические рассказы, сказки [Towards the Unknown Lands. A Collection of fantastic and fairy-tales] (St.-Peterburg: A. Terentyev Publishing House, 2022) and *Buddhism in Buryatia, 17th-beginning of the 21st century* (Dharamsala: Library of Tibetan Books and Archives, 2024, with Irina Garri).

**Irina Garri** (Ph.D., Institute for Mongolian, Buddhist, and Tibetan Studies of the Siberian Branch of the Russian Academy of Sciences, IMBTS) is a Leading research fellow, Associate Professor at IMBTS. A Historian of China and Tibet, her research focuses on Sino-Tibeto-Mongolian relations, History of Buddhism in Tibet and Buryatia (Russia), Buddhism and nationalism in Inner Asia. Her latest publications are a translation from Chinese into Russian of the *Life of Arjia Rinpoche and the Secret of the Golden Urn* (2017) and *Buddhism in Buryatia, 17th-beginning of the 21 st century* (Dharamsala: Library of Tibetan Books and Archives, 2024, with Alexander I. Andreev).

**Bianca Horlemann** (Ph.D., Goettingen University) is an independent researcher from Germany. Her research interests cover different aspects of the history of Sino-Tibetan relations in northwest China and Amdo such as the 10th/11th century Tsongkha tribal confederation, political and economic aspects of Tibetan-Muslim relations, 20th century Golok history, and the Christian missionary enterprise in northwest China. Her latest research examines the multi-ethnic network of contacts between Tibetan, Chinese, and Muslim elites in Gansu and Qinghai. Her forthcoming publication is titled “Ma Qi, the First Muslim Warlord of Early 20th Century Xining, His Network of Contacts to

Tibetan Elites, and the Tibet Question,” in a special issue of the *Central Asiatic Journal*.

**Yumiko Ishihama** is a tenured faculty member of the School of Education, Waseda University, Japan, and the author of numerous English and Japanese language articles in the field of Tibetan and Inner Asian history. Her latest publication is *The Early 20th Century Resurgence of the Tibetan Buddhist World* (Amsterdam: Amsterdam University Press, 2022; with Alex McKay).

**Fabienne Jagou** (Ph.D., Paris, École des Hautes Études en Sciences Sociales, EHESS), historian, is Associate Professor with habilitation at the École française d’Extrême-Orient (EFEO), Paris. Her research focuses on the political and cultural relations between Tibet and China from the eighteenth century to the present. She is the principal investigator of the ANR funded project (ANR-21-CE27-0025-Natinasia) entitled “Building Nationalism in Inner Asia: the Empowerment of the Tibetan Revolution in the Early Twentieth-century” (2022–2026). Her latest publication is *Gongga Laoren (1903–1997): Her Role in the Spread of Tibetan Buddhism in Taiwan* (Leiden: Brill, 2021).

**Ling-Wei Kung** (Ph.D., Columbia University) is a historian of modern China and Inner Asia, with a research focus on the circulation of information and knowledge across trans-regional contexts adopting a multilingual and interdisciplinary approach, his research draws on sources in modern and classical Chinese, Tibetan, Mongolian, Manchu, Japanese, Russian, and various European languages. His latest publication, “The Issues of the Sixth Dalai Lama and the Transformation of Qing Information System on Tibet,” appears in *Religions* (A&HCI).

**Scott Relyea** (Ph.D., University of Chicago) is Associate Professor of East Asian history at Appalachian State University (USA). A historian of late imperial and modern China, his research focuses on political, social, and intellectual history with a current regional focus in the southwest borderlands encompassing Sichuan province and the Tibetan plateau. His research centres on nationalism, state-building, ethnic construction and identity, and the global circulation of concepts of statecraft and international law in the late nineteenth and early twentieth centuries.
